**Application Deadline:** Vendor applications and payments are due **no later than January 10, 2024.**

**\*\*\*Early Bird Special: applications and payments received by December 31, 2023, will receive \$20 off for the event.\*\*\***

**Loading and Unloading:** Vendors may use any of the open entrances to the event center. After unloading your vehicle(s), please move your vehicle(s) to the appropriate parking area for vendors (see **Parking** below). ***Do not leave your vehicle at the entrances while unpacking/packing up your booth.***

**Set Up Times:** Set up times will be Friday 6-8pm and/or Saturday/Sunday 7-8:30am.. If you need to set up earlier, please contact Lena Cardenas (308) 660-5077 or Hope Rumery (308) 660-8004.

**Parking:** During event times, vendors should park as far away from the entrance to the event center as possible, with the exception of those who require a handicap parking space.

**Taxes:** Vendors are responsible for collecting their own sales tax, if applicable. This includes city and state taxes.

**Trash:** You are responsible for keeping your area clean. There will be a few trashcans throughout the venue for your convenience.

**Restrooms:** Restrooms are available inside the event center.

**Cancellation Policy:** No refunds will be issued for any cancellations.

**No Early Teardown:** In order to avoid disruptions to customers and other vendors, early teardown is not permitted. Exceptions will be made on a case-by-case basis for emergency situations, at the discretion of *Triple Bee.*
